Meeting Report

Department of Health, Humanitarian Affairs and Social Development : Ending Harmful Practices Unit







Background

A major hindrance to progress in Ending Harmful Practices (FGM and Child Marriage) is the limitation of knowledge, information, and the right communication on the effects of these practices especially at the most rural and remote and underserved places where they mostly occur. There's also a lack of accountability and enforcement of nationally agreed on policies by key stakeholders at the grassroots level including village chiefs, traditional and religious leaders as well as educational institutions.

Due to its wide range of channels, Mass media (digital, live, print, and social), is a critical tool for connecting people and generating discourse on issues that are affecting their quality of life. Media Engagement is key to the success of AUC's two campaigns on Ending Child Marriage and Elimination of Female Genital Mutilation. This is because mass media can share critical legislative information on the campaigns across all levels in the member states; it can expose geographical areas where these harmful practices occur including their perpetrators and promote advocacy for national campaign plans by holding local leaders, community members, households and individuals accountable for protecting girls and women from these harmful practices and their debilitating effects on development.

Gauging from the current projections of more than 50 million girls at risk of being subjected to female genital mutilation [UNFPA-UNICEF JP on FGM]; and more than 120 million girls who will be forced into child marriages by 2030, and the critical role, coverage, and the strong reliance of Africans on media for social and developmental information; the African Union in its mandate to accelerate an end to harmful practices, conducted the first of Two Media capacity building sessions on Sensitive Reporting on Harmful Practices for 34 Media professional (gender reporters, gender media scholars and university journalism faculty members) from 10 East and Southern African Countries: (South Sudan, Somalia, Ethiopia, Kenya, Tanzania, Malawi, Mozambique, Zambia, Zimbabwe and Tanzania). The 3-day training was held from 5-7th July 2022 at the Best Western Hotel, in Nairobi Kenya, with leadership from the AUC Health, Humanitarian Affairs and Social Development Division- Ending Harmful Practices Unit and support from The Spotlight Initiative Africa Regional Program through UNICEF and UNFPA, as well as Plan International and World Vision. The technical capacity building session was led by the Global Media Campaign on Ending FGM.

Objectives of the AUC Media training on Sensitive Reporting on Harmful Practices for East and Southern Africa Countries (5-7th July at Best Western Hotel, Nairobi, Kenya)





The training aimed at achieving the following specific objectives:

- To engage at least 20 university journalism faculty members from 20-member states in a training for trainers' session that will generate content for a comprehensive human right cantered media reporting curriculum for pre-service and in-service media reporters. Journalism faculty members' engagement is perceived to ensure the sustainability of learning on accountable harmful practices reporting.
- To orient and build the capacity of at least a total of 30 journalists and university journalism faculty from 10-member states on the AU ECM and FGM campaigns and their critical role in human rights-based reporting, communication, information dissemination, and advocacy for the protection of girls from harmful practices.
- To engage 30 gender media practitioners and 10 journalism master's degree scholars from the 10-member states in supporting the development of a curriculum on human rights-based reporting on harmful practices.
- Action media: To engage at least 30 journalists and university journalism faculty from 10-East and Southern Africa member states in brainstorming and developing tailored media advocacy and social behaviour change messages that will be used at the member state level to raise awareness and increase accountability of each category of stakeholders in protecting girls against harmful practices.
- Through the media contacts established from the training, create a network of Africa-wide Harmful Practice media representatives who are coordinated, engaged, and exchanging experiences, lessons learned, and best practices in human rights focussed reporting against Harmful practices that affect African girls and in line with the FGM and ECM campaigns.

Selection process of the Media trainees

On 11th May 2022, working with the AUC Division of Communications and the partner's Technical Working Group, the AUC EHPU issued a call for applications for Media professionals to the ESA countries which covered the basic skills and experiences required by applicants particularly experience in reporting on gender and child protection issues. Up to 234 applications were received from the 10 countries and AU EHPU together with partner representatives from UNICEF and UNFPA constituted a selection committee which came up with a list of highly qualified and experienced media finalists from the 10 countries who were subsequently informed of their selection for the training. Additionally, World Vision International nominated four CSO representatives from Kenya who are working in Ending Harmful Practices.

Participation in the training





The training had a total attendance of 60 physical participants and up to 10 virtual participants who included:

- Media trainees (34 participants) including 7 from Kenya, 2 from Somalia, 4 from Ethiopia and 3 from the rest of the countries.
- 5 UNFPA staff including the Deputy Country Representative of Kenya
- 3 AUC staff
- 4 World Vision International Staff including the Regional Advocacy Director
- 5 Plan International staff including the Director AU Liaison office
- 5 UNICEF staff including the Representative to AU and ECA
- 3 staff from the Global Media Campaign

Modality of the training

The training was led by the AUC EHPU in collaboration with the UNFPA supported Global Media Campaign and covered several approaches aimed at creating an exposure, understanding and appreciation of the causes, effects and much needed actions to change harmful practices. The sessions were tailored according to the regional context and had partner representatives and key stakeholders share their experiences of effective interventions that are in place to End Harmful Practices. The different approaches used for the training include:

<u>Exposure to field best practices</u> including a panel discussion that engaged key stakeholders in sharing experiences on how they are engaging the media to lead actions against harmful practices including: Ms Mona Aika the Child Protection Specialist UNICEF ESARO, Mr Frederick Mariwa, Project Manager DW Akademie-Kenya, The Senior Cheftainess Chikumbu Deleza from Malawi, Mrs Maggie Banda from Womens Legal Resource Center- Malawi, Ms Alice Salaita a Plan International Young girls Ambassador and Ms Roseline Hwati from RIATT-ESA secretariat.

<u>Country presentations:</u> to allow for a better understanding on the country contexts and effectively guide the necessary training support, the media professionals made joint presentations on the existing reporting practices on harmful practices, their strengths, weaknesses and areas of much needed improvement.

Human rights based reporting case studies and technical exercises: these formed the main fabric of the training and saw participants take on individual and group exercises and presentations that were initiated by exposure and criticising of real live and print media stories that either followed or negated the key principles of protecting the victims, exposing the perpetrators and impactfully advocating for justice for children affected by harmful practices. Trainees were tasked to reflect on their own stories and identify elements and areas of improvement to widen the reach and engagement of their ending harmful practices narratives.

<u>Work planning:</u> this session finalised the training and gave an opportunity for each trainee to commit to developing a series of key topics and persons to engage in developing impactful stories on harmful practices as well as key messages for stakeholders who are at the helm of influencing these harmful practices. The university Lecturers in particular drafted curriculum





outlines for sensitive reporting on harmful practices. Each trainee was awarded a certificate of attendance to confirm their participation and learning through the training.

Outputs from the training

- Up to 34 media practitioners were skilled on human rights-based reporting in line with the African Union Campaigns on Ending Child Marriage and Female Genital Mutilation
- The 12 Journalism lecturers were engaged in a brief curriculum development session which resulted into outlines of local curriculums on media reporting in reference with the African Union Campaigns on Ending Child Marriage and Female Genital Mutilation that are scalable for empowering pre and in-service frontline media professionals.
- Key messages for different stakeholders were generated by the media professionals which will guide country-based advocacy and engagement through media in reference to the two AUHPU campaigns.
- A network of East and Southern Africa media practitioners and faculty members was formed including a WhatsApp group which will facilitate the continued engagement, experience and best practice sharing of the media practitioners on Ending Harmful Practices.

Lessons learned and Recommendations

- Media practitioners selected are already developing and publishing content on gender and child protection, however, they are not supported to translate these stories which often involve victims into legal action. Its therefore key that CSOs and government agencies work closely with the trained media to follow up on reported cases.
- The Media training collapsed in three days doesn't provide ample time for the trainees to internalise and fully contribute to the expected outputs on reporting on harmful practices.
 A 5-day training schedule is recommended for the next training.
- Engagement of the trained media professionals in ongoing partner, AUC and government led activities is key to the attainment of the training objectives. The AUC will share the list of trained media professionals with member states and partners to enable them to incorporate these individuals in their existing and planned interventions related to Ending Harmful Practices.

Next Steps

- The AUC will conduct the next training session in mid-October 2022 and this will engage 36 media professionals from 11 West, Central and North African countries (Djibouti, Egypt, Ghana, Nigeria, Liberia, Sierra Leone, Senegal, Niger, Chad, Mauritania and DRC in a similar capacity building session.
- AUC will engage the trained participants in all ongoing country and continental level Ending Harmful Practices campaign activities.
